# 2024/13337 CONDITION OF STOCK - REPORT BY THE HEAD AGISTER

**RESUME** 

The Head Agister said that the continuing wet weather is taking a toll on the condition of stock. From now until the end of April is always considered to be the 'hungry time' on the Forest. This year, although it looks green, there is very little food on the Forest for the animals. As always young ponies who are changing their teeth and mares with foals still on them are the animals which the weather is impacting the most. The Agisters and commoners are busy removing animals as required. The Head Agister said that at the moment he feels they are not overwhelmed.

The condition of stock over the next few weeks and months will be very much weather dependent. A dry spell is desperately needed.

Mr Deakin expressed concern that with the Forest looking green, some commoners may be tempted to turn out animals too early. This is always a problem but may be worse this year.

# 2024/13338 STRANGLES

RESUME

Strangles rumbles on with a few animals in various areas of the Forest showing symptoms. The latest new cases have been seen on Holmsley and Long Cross.

2024/13339 CATTLE DISCHARGE

The TB testing window is coming to an end. The Agisters have been busy marking cattle and helping commoners when their animals are TB tested. There is not a huge number of cattle on the Forest, only those whose owners have feeding areas. Those are much fewer now.

A discussion place on stock numbers. The Official Verderer said he struggles to explain to other people and organisations, why it is believed commoning is in decline when the number of animals has increased.

Mr Deakin said that commoners are holding onto animals, particularly cattle, because they believe a new headage subsidy will be introduced. The cattle allowance paid last year may also have encouraged some commoners to keep animals that they may otherwise have sold.

Long-standing commoners will probably continue but some are reducing their stock. Some commoners have had cattle marked in order to obtain a receipt in case it is needed to claim subsidies later but they have then sold some, and retained fewer animals. Those cattle may never be turned out and therefore they never benefit the Forest.

Keeping cattle requires significant investment in equipment and, unlike with ponies, if commoners get out of cattle, getting them back is much more difficult. A lot of the cattle are owned by a few commoners and many are getting older. It is very expensive for young commoners to get into cattle.

#### 2024/13341 BREACHES OF THE BYELAWS

RESUME

There are no current breaches of the byelaws. Mr Deakin said that all the 2 year old colts that were at large have been caught. He added that this is thanks to the Agisters' efforts and a small number of commoners who helped more than they strictly needed to.

## **ENCROACHMENTS NOT INVOLVING FORESTRY ENGLAND**

## 2024/13342 SHOBLEY/FOREST OAKS

RESUME

The deadline for the removal of the illegal fencing and other items has not yet been reached and nothing has yet been removed. If the agreed actions do not take place, the land owner will be in breach of his agreement with Natural England. NE is monitoring the situation and if needed, will make a judgement once the deadline is passed.

# 2024/13343 NEWLY ERECTED FENCE IN WOODLANDS ROAD, BARTLEY

**DISCHARGE** 

A new security fence has been erected for which the land owner has applied for retrospective planning permission. Whilst construction was taking place, the property owner received some advice from the Forestry England Keeper, Mr Patrick Cook and Mr Deakin. Despite the advice, the fence has encroached on the open wastes of the Forest in a couple of places and the CDA and Court have submitted objections to the planning application on that basis. It is thought the 8ft fence is out of keeping with the traditional character of the Forest and breaches planning guidance.

#### ANNOUNCEMENTS & DECISIONS

#### 2024/13347 ROAD TRAFFIC ACCIDENTS & AVERAGE SPEED CAMERAS

We are still seeking clarification from the Department of Transport regarding the status of their Circular 1/2007, as that is the cornerstone of Hampshire Constabulary's Joint Operations Unit for Roads Policing's (JOU) objection to the introduction of Average Speed Cameras. Hampshire Constabulary's other comment, that third-party funding is not acceptable, is surprising given the funding accepted by the Constabulary over a number of years in support of additional deployments of the mobile speed camera van within the Forest. We are expecting confirmation that local police and highway authorities should be adapting Department of Transport guidance in light of local circumstances.

We have extended an invitation to the Chief Constable and Head of Roads Policing to meet with the Court.

## 2024/13348 CONFLICTS WITH COMMONERS' ANIMALS WITHIN THE NEW FOREST

Everyone agrees that greater effort must be made to reduce the risk of conflict between animals and people in the Forest. A great deal of discussion has and continues to take place, within the organisations and agencies with responsibilities for the management of the Forest, but the problems persist. We are hoping to arrange a meeting of key people from Camping in the New Forest, Forestry England and the other organisations to try to find an effective way forward.

Greater public education is essential. We are seeking a formal strategy, to be put in place before the start of this year's camping season. The risk to people, commoners and the stock cannot remain at the current level. The New Forest National Park Authority will be asked to assist with effective communication.

## 2024/13349 ILLEGAL ENCROACHMENT AT BARTLEY - FOREST GLADE HOUSE

It is not for the Court to decide the way forward to resolve this dispute. A land swap will be considered, should Forestry England bring forward a proposal that is supported by all landowners concerned. However, it will have to be on a value basis not area for area. The Court has generally only agreed land swaps in exceptional circumstance and where such a swap is in the public, rather than merely a private interest.

### 2024/13350 ICE CREAM VAN AT BOLTONS BENCH

It is Forestry England which grants licences for ice cream concessions, not the Verderers. We understand the Deputy Surveyor will be making a presentment today. In accordance with the Memorandum of Understanding with Forestry England, the Verderers may not unreasonably withhold their consent for ice cream sales. Matters we consider when agreeing suitable locations include the impact on livestock, risk of increased littering and the effect on the local amenity.

#### 2024/13351 MARKING FEES FOR THIS YEAR 2024

We would like to remind commoners that as announced previously, unfortunately marking fees have had to increase this year.

We are receiving some fees at last year's rate which is causing difficulties for those commoners who are having to make supplementary additional payments as well as our office. The fees for 2024 are on our website and can be found under Announcements. They are also on our Facebook page.

# 2024/13352 LIVESTOCK MANAGEMENT

The Verderers would like to remind members of the public that management of the depastured stock is a year round activity and not, as for example in the case of ponies, restricted to the drift season. The office, Agisters and Commoners, all often receive complaints from members of the public when they are inconvenienced by both essential and sometimes routine activities.

Animals are often caught by stealth, using food perhaps moved daily to move them gradually to a pen or the home holding. In the case of cattle, this can result in large numbers congregating in unusual places. More often ponies are caught by being driven to a pen on horseback. It is not possible to erect signage to warn of this activity, as it is not possible to predict where the animal will be found, or in which direction it will choose to try and make an escape. Pens are located in many places, and a decision regarding which one to use will be made once the chase is underway.

These activities must take place to ensure that welfare standards are maintained to a high standard, and that DEFRA requirements are met. They may involve just Agisters, a team of Commoners and Agisters, or Commoners alone. We will do their best not to alarm members of the public, but animals can be unpredictable, and unfortunately there is no longer quiet times when any part of the Forest is devoid of visitors. It should be noted that Commoners also have a "day job" and they have to tend to their depastured stock's needs mostly at weekends.

Ponies, in particular, will sometimes gallop about for no obvious reason, because of their flight instinct. Whether being driven or not, the advice is always to stand still if there are no bushes or trees nearby behind which to seek shelter. It is very rare for a pony to deliberately run into a person. They will generally do all they can to go round you.

In all circumstances, it is important to allow the Forest animals plenty of space.

# 2024/13353 GARDEN WASTE

Because of the mild winters we are now experiencing early growth on shrubs and hedging is common place. A commoner has recently collected and removed a large bag of yew clippings from the open Forest on the side of the road at Stoney Cross. Yew is lethal to animals and should never be left where Forest stock can eat it.

Lawns are also growing at this time of year now and lawn mowings are another type of garden waste that is extremely dangerous to ponies and donkeys.

Discarding garden waste of any kind by dumping it on the Forest constitutes fly tipping and is illegal.

## 2024/13354 THE ANIMAL ACCIDENT REPORT FOR JANUARY 2024

The Agisters attended 2 accidents in January compared with 8 in January last year.

1 donkey was killed and nothing was found injured following a report of a pony being involved in an accident with a car.

1 accident happened in daylight, and the other in the dark.

Both drivers involved reported having been involved in an accident with a commoners' animal.

The total number of commoners animals killed and injured this year is 1.

#### PRESENTMENT BY THE DEPUTY SURVEYOR

#### 2024/13355 MOBILE REFRESHMENT SALES

'A number of presentments and wider commentary have been made in recent months regarding the sale of ice creams and other refreshments at a small number of Forestry England car parks. In response to these, I thought it might be useful to provide some information on how Forestry England cares for the New Forest landscape and funds the facilities we provide.

We carry out a wide range of work to ensure the ecological importance of the New Forest is protected and enhanced. We also provide numerous facilities to ensure everyone spending time here can access the benefits of being in nature and provide information so they understand how to enjoy it responsibly.

The vast majority of Forestry England's work is self-funded. Government funding has significantly declined over the past 15 years and now only 12% of our income comes directly from government. All of the funds we raise go directly back into caring for the Forests we look after and providing facilities.

In the New Forest, given the level of protection and support needed for such a special landscape, we spend far more than the revenue we generate. Our work has for many years now been largely supported by funds generated by Forestry England in other parts of the country. This is not a wholly sustainable position and has been recognised by all local forest organisations as needing to be addressed. Specifically, the Recreational Management Strategy for the New Forest includes an action to increase revenues in order to fund environmental and social improvements.

In addition to our forestry and habitat restoration work, in the New Forest we also look after a network of 130 car parks, maintain hundreds of miles of trails, paths and cycle routes, and run visitor-focussed ranger patrols. These activities all play a significant role in making the New Forest a popular destination for visitors, local people and residents which in turn helps support tourism and the local economy.

Specifically in Lyndhurst, the ice cream sales at Bolton's Bench help to support the maintenance of this large car park which plays a key role in supporting parking for the village itself and visitors to the New Forest. The high demand for parking at this location brings with it significant maintenance cost. For example, the most recent tarmac repairs required at this site cost in excess of £80,000. The site is also supported by regular patrols providing educational information, including Public Space Protection Orders, plus regular emptying of bins, litter picking and other maintenance.

To be able to continue to provide these services, and effectively manage the visitor numbers they support, we have to generate revenue. Mobile refreshment sales in some of our car parks have for many years been just one way that we raise funds. These sales will be available at 17 of our 130 car parks. All locations are carefully picked and chosen where existing facilities are in place and the areas are more suitable and robust for visitors.

The tender for these services this year has included a number of changes including looking for more sustainable providers with a positive environmental and social impact. It also highlights opportunities for local business and local produce to be included in the offer.

We have encouraged local refreshment businesses to consider this opportunity. Members of our team have contacted businesses in Lyndhurst High Street and beyond to make them aware of the tender opportunity.

Those companies who are successful will be contractually required to meet conditions around managing litter and helping us to deliver key educational messages including not feeding or petting livestock and the Public Space Protection Order rules.'

Presentment by Mr Andrew Parry-Norton, Chairman, The New Forest Commoners Defence Association

'Good morning official Verderer, Verderers and court members

The New Forest Commoner's Defence Association, Andrew Parry- Norton (NFCDA Chairman)

As I am sure you are aware the Forest Farming Group is now making progress with the PA2 study due to start soon. This study on conclusion, will hopefully give us an indication of which scheme would work best for the Forest.

The potential scheme should deliver justifiable rewards for the dedication and hard work the Commoners put into caring for their stock. The foundations of the Forest ecology and landscape are dependent on commoning.

Unfortunately, the future still remains far from certain for Commoning, politicians unlike Commoners never seem to keep their jobs for long. A new Government could trigger a change in funding or schemes.

Therefore, we must have a plan B in the event plan A doesn't deliver for the Commoners. This will require outside of the box thinking by all the Forest Organisations especially the Verderers.

The commoners create the landscape that attracts 17.5 million visitor days a year, a 500 million pound industry, according to figures from Go New New Forest; Tourism might be a potential revenue source but we need to explore all options.

The CDA will remain fully committed to finding a suitable scheme but strongly recommend the Verderers work with us to look for a plan B. The Commoners deserve a secure viable future; let's not trust Defra to supply all the answers.'

# 2024/13357 FOOD VANS IN FORESTRY CAR PARKS Presentment by Mr Brian Tarnoff

'I wanted to respond directly to the deputy surveyor's presentment, because there are so many ideas in it, that need to be smothered now, as soon as possible.

We've just had an announcement that you are processing the whole issue of interaction with livestock. I stood here probably a little over 10 years ago to counter a similar scheme where they wanted to put shop facilities in the campsites.

To bring in a source of food and litter into our carparks throughout this Forest is counterproductive to the issues we're currently facing.

And yes, I understand the whole funding issue, but there's a legal obligation for Forestry to deal with the habitat and the heritage issues of the Forest, and central government is not funding their work in this endeavour sufficiently. That is the crux of the problem, not putting them in a position where they have to engage in activities in order to create revenue streams that are from activities that are contrary to the mission of preserving the forest.

There is the mandate that Forestry has to manage the Forest, which places the conservation of the Forest above the revenue seeking activities.

The Court suggested that as this is a contentious issue, more detail is required for public consideration, including the full list of sites. In response, the DS pointed out that all the details are contained in the tender offer on Forestry England's website. The Court, however, regrettably felt that is not sufficient.

Upon receipt, this will be published by the Court on its website and Facebook page.

The Court anticipates a response from the Friends of the New Forest (New Forest Association) and others at the next Court.

A decision will not be made until after the March Verderers' Court, in order to allow the opportunity for public comment.

2024/13359 PLAN B RESUME

The current effort to prepare and submit an application for future funding is not progressing with the speed necessary to support the financial viability of Commoning and other options must be considered. The Court will consult with all partners. Once the PA2 funding has been confirmed, a meeting will be set up with the chosen consultant.

In addition, vulnerable road users such as walkers, cyclists and horse-riders would be put at risk. The Court is concerned for the knock-on effect on management of the Forest, rather than the principle of charging, and was unanimous in its objection to the introduction of parking charges in these car parks.
