Some commoners are getting their animals in because of the acorns although the acorn crop is patchy and not as heavy as anticipated. A good number of pigs are out with the usual problems with poor fencing meaning a few pigs are escaping from the Forest.

Mr Readhead said he has never seen the animals on the Forest looking so good.

ANNOUNCEMENTS & DECISIONS

2023/13120 VERDERERS GRAZING SCHEME ENHANCED PAYMENTS

In June we heard a presentment from Mr Adam Coutts, a Commoner whose stock grazes the Northern National Trust Commons. Mr Coutts is unhappy about what he believes is the unfair distribution of financial support provided to commoners under the Verderers' Grazing Scheme.

The Court understands Mr Coutts views, but it is simply the case that other owners of common land within the Forest were not in a position to contribute funds towards an additional cattle supplement which was paid to commoners whose animals graze the Crown Lands. The supplementary payment, which was over and above the usual annual payments, came from the Verderers VGS fund. Animals which graze land which is not in the VGS, cannot receive payments unless funding is provided by the land owner.

Unless a new agri-environment scheme can be secured which covers the whole Forest, this inequality will regrettably continue.

2023/13121 CLAYPITS BOTTOM

Following Mrs Farrand's presentments in our July and September Open Courts, the Deputy Surveyor said that the proposals for Claypits Bottom were discussed and agreed at the May New Forest Freshwater and Wetlands Restoration Forum. It is understood that while the view of the Forum was not agreed unanimously, the proposals were supported by a majority of Forum members.

Geological reports were carefully considered and when the works were undertaken, care was taken to ensure that no damage was caused to the area of geological importance. We were told the proposals were also discussed at Quadrant Meetings and the Consultative Panel. An explanation of the work carried out at Claypits Bottom, and the reasons why they were needed, is available on the Verderers' Higher Level Stewardship Scheme web pages online.

2023/13122 AVERAGE SPEED CAMERAS ON THE B3078 ROGER PENNY WAY

Firstly, we want to thank Mrs Gilly Jones for the excellent job she is doing to reduce road traffic incidents involving the commoners' animals. She has done more than anyone else to help reduce animal accidents.

Following the completion of a feasibility study led by Hampshire County Council, the only barrier, other than the availability of funding, to installing Average Speed Cameras on the B3078 Roger Penny Way is the Joint Operations Unit for Roads Policing (JOU) interpretation of Department for Transport Guidance which, in their view does not support their introduction. We continue to pursue this at the highest

level in the hope of obtaining either clarification from the Department for Transport or an amendment to the guidance.

2023/13123 REPORTING OF ROAD TRAFFIC COLLISIONS BY DRIVERS

The issue of drivers delaying the reporting of accidents is extremely concerning, as is the failure by some drivers to report accidents at all. The Accident Report we are about to hear will sadly confirm that last month's data seems to indicate a very worrying increasing trend.

Whilst the law says drivers must report an accident as soon as practicably possible, and in any event within 24 hours, in the case of an RTC involving an animal which may be badly injured, the report should be made immediately. Under the Animal Welfare Act, there is an obligation to reduce suffering. We are writing to Hampshire Police asking if consideration can be given to taking drivers to task who don't report animal RTC's promptly. Prosecuting drivers for hitting animals has not been encouraged because it may discourage them from reporting accidents, and the Court continues to support this position, where a collision is reported promptly. A driver who reports an accident in a timely manner is almost never prosecuted, unless of course he/she is guilty of some other offence. The likelihood of police taking action for another reason may, of course, be why some drivers don't report accidents. They can, however, make an anonymous call, in order to avoid unnecessary suffering to the unfortunate animal involved. Leaving an animal laying for hours in a ditch with broken limbs is not acceptable.

2023/13124 BEAULIEU VILLAGE SPEED LIMIT PROPOSAL

The Animal Accident Reduction Group (on which Mrs Jones sits) met last month and the question of reducing the speed limit to 30 mph in Beaulieu Village on the road up to Hilltop was discussed. From an animal accident perspective, that particular stretch has not been identified as an area that has a significant prevalence of animal casualties and the Group decided, therefore, not to pursue that suggestion.

2023/13125 LICENSING OF COMMERCIAL DOG WALKERS

Forestry England has advised that it does not intend to progress this at this time. The Court will continue to encourage it to review its position.

2023/13126 AGRI-ENVIRONMENT SUPPORT PAYMENTS TO COMMONERS

The Forest Farming Group continues to explore possible future schemes to support commoning. The aim is to support commoning in a fair but sustainable way, to ensure the optimum number of animals are depastured in order to maintain the Forest's natural environment.

2023/13127 PUMPKINS

Halloween is in a few weeks' time. In the past, people have thought that discarding pumpkins on the Forest is helpful to the animals. It isn't and pumpkins can in fact be harmful when eaten by livestock, although they are thankfully usually uninterested in them. As a result most pumpkins are just left to rot and therefore constitute fly tipping so, we therefore ask members of the public to please not leave pumpkins on the Forest.

2023/13128 CLOCKS CHANGE

The clocks change on Saturday 28th October which means it will be dark at commuter time. Historically, the winter months always bring a spate of road accidents involving Forest animals as drivers tend not to adjust their driving habits as they travel on the unfenced roads in the dark. PLEASE slow down when you drive on the open Forest roads. If a vehicle is coming towards you your ability to spot an animal on the verge or in the carriageway will be compromised. Hitting a large animal will result in significant damage to your vehicle and will delay your journey. At worst, drivers and their passengers may be quite seriously injured and will more than likely suffer from the effects of shock.

We've all been blinded by oncoming lights. Please slow down.

ANIMAL ACCIDENT REPORT

2023/13129 THE ANIMAL ACCIDENT REPORT FOR SEPTEMBER 2023

The Agisters attended 12 accidents in September this year compared with 6 in the same period last year.

5 ponies, 1 cow, 1 pig and 3 sheep died.

2 ponies and a cow were injured.

2 ponies reportedly in road accidents couldn't be found.

9 accidents happened in the dark, the other 3 in daylight.

5 drivers failed to report having collided with a commoners' animal.

The total number of animals killed and injured in the year to date is 35, compared with 33 in the same period last year.

PRESENTMENTS BY THE PUBLIC

2023/13130 ASHURST HOSPITAL Presentment by Mr Richard Reeves

This presentment is made on behalf of the New Forest Association in regards to the future of the Ashurst Hospital site.

The site was originally part of the open waste and commonable lands of the New Forest. In 1836 and 1848, two grants were made of this land to the New Forest Poor Law Union for the erection of a workhouse and associated agricultural plot. These grants included a reverter to the Crown once the land was no longer required for that purpose. In 1948, the land was transferred to the National Health Service. The Crown's right of reverter may be lost, but this does not have any bearing on the common rights which have been held in abeyance since 1836 and 1848 respectively. The Verderers have always maintained that the land is subject to common rights and, in 1988, they were able to recover an undeveloped parcel of the land. In 2019, the remaining enclosed land was identified for development in an Additional Site Allocation to the Local Development Plan when the Verderers again reiterated that the land is subject to common rights. I will now cover three aspects, the principle, the land, and the heritage.

Firstly, the principle. Last month, at a National Park Authority Planning meeting a dual application was made by Southampton NHS Trust to extend the existing hospital on the one part and demolish the old workhouse buildings and sell the land to a private developer for the development of a 70-unit care home on the other. While the hospital extension cannot be a cause for argument, the outline plan indicates that the care home development would encroach upon some of the currently undeveloped lands nor return any land to the Forest. This disregards the commoners' interest, diminishes the Forest and is purely for short-term commercial gain. Surely, this proposal should not sit lightly with any authorities with an interest in the New Forest.

Secondly, the undeveloped and/or easily recoverable land amounts to a little under 4 acres which should be returned to the Open Forest with the restoration of common grazing and public access. As to the other previously developed parts, about 3 acres, the NHS might be best advised to provide exchange land so as to secure itself unencumbered freehold.

Thirdly, heritage value. The vast bulk of the original structure, built in 1836, to the design of Sampson Kempthorn, remains (he was the lead architect in the workhouse movement). Another important historical player in this movement, the Rev. Herbert Smith, is also intrinsically linked to this site (his published output helped shaped societal views regarding the deserving and undeserving poor). This contrasts with the factually incorrect evidence supplied in the heritage consultant's report to the NHS. To demolish a structurally sound historic building, important on a local and national scale for a care home development is little short of vandalism. I would suggest it be retained and developed to meet the local affordable housing need (if the NHS can really find no reasonable use), rather than being sold off to meet a rather oversupplied (though perhaps more lucrative) demand for care homes. An application for listing the workhouse buildings is currently pending in the offices of Historic England.

In summary, we are in the absurd situation whereby a government agency is seeking to demolish significant built heritage to facilitate selling off part of the New Forest to a private developer, thereby denying commoners grazing land and the local population additional open space, all within the core of the National Park. I therefore ask the Verderers to seek redress in these matters. Thankyou.

Mr Parry Norton added that the CDA supports this presentment.

2023/13131 GRASS CUTTING RISKS WITHIN CRICKET GROUNDS Presentment by Mrs Jacquie Vanderhoek – read by Mr Andy Parry-Norton

'Prior to Bartley Cricket ground being opened to livestock at the beginning of October I observed a huge pile of the seasons grass cuttings stored by the tree within the ground. I was concerned to see this method of storage over the Summer Season especially as stock do manage to enter the grounds on some occasions as witnessed recently at Cadnam Cricket ground, prior to it being officially opened to stock out of season.

At Bartley it appears the stack of cuttings was not removed prior to it being opened around the beginning of October as I observed the remains of the pile, presumably eaten, trodden in and scattered around the area. Dry remnants of the cuttings could be seen scattered but underneath was decomposed matter because of its long storage time.

I raised concerns with my agister in case there were any cases of colic reported in the area.

I would like to raise such concerns about the responsibility of storage and disposal of cuttings and its implications on the health of commoners' animals.'

Mr Parry-Norton said the CDA supports this presentment.

2023/13132 THE NATIONAL TRUST - A RARE AND ENDANGERED FOREST RESIDENT Presentment by the New Forest Commoners' Defence Association, Andrew Parry-Norton (NFCDA Chairman)

'The New Forest is renowned for its rare and endangered species; many plants, birds and animals are in serious decline. Probably the rarest in the Forest is the National Trust. Sightings have become extremely infrequent since Lock Down.

As one of the larger land owners in the Forest the lack of engagement at all levels will have a detrimental effect on the Forest and the Commoning community. The National Trust no longer has a dedicated team to manage their land holdings; staff have left and are not replaced. Contact with a warden is virtually impossible.

I enclose and read out, an extract from an email sent to one of our committee members from a member of staff from the NT

"We are not currently in a CS agreement (the old HLS agreement funded the works we did on the commons but we are not in one currently) and there is no management plan for the commons and hasn't been since the old HLS ran out."

We, the CDA, understand that a management plan is not required by law but as a public charity that should be a bare minimum. The law does require that SSSI's are maintained and improved, they are not allowed to fall into unfavourable conditions, a management plan is critical to this obligation.

We request that the Verderers take a very strong stance with the NT, remind them of the obligations to the Commons and the Commoners. Insist that they engage in talks regarding potential future schemes and most importantly take proper care of their land holdings. Thank You.'

2023/13133 CLAYPITS

Presentment by Mrs Ailsa Farrand

'Official Verderer, Verderers, Ladies and Gentleman - I am Ailsa Farrand, a commoner, the vice Chair of the New Forest Equestrian Association representing them on the New Forest Consultative Panel for nearly 20 years, and I sit on the Freshwater and Wetlands Restoration Forum.

Referring to the July minutes recently posted, they state that a response would be drafted to my July presentment and a copy supplied to the DS who is requested to come to the court with any comments. I have not had any communication relating to my July (or September) presentments.

However I would first like to point out an error and a mis-representation in the July Verderers Court minutes. Firstly the statement that the Claypits Bottom site was discussed and approved by the Freshwater and Wetlands Restoration Forum is incorrect.

 Claypits Bottom was not discussed at that FWRF meeting - although I flagged up the need for a site visit due to its importance. Picket Mire was discussed and has now been carried out. I invite anyone
who knew the Picket Mire site before the work to see how one hole has been
turned into a series of knick points with clay and infill materials on the surface.

The importance of the Studley Wood Geological feature was highlighted when the Forestry Commission (as it was then) commissioned a survey by a specialist company in 2010 on the feature. This Report was not made public, until obtained under a Freedom of Information request. It detailed how rare and important the site was in Europe and the only one of its type in Southern England. The works at Claypits Bottom are already eroding and presumably the infill materials will be washed down to the site as with the previous repairs.

Secondly, in the July minutes there is clear criticism of myself and one other for opposing works which is an unfair representation. I have only voted against one motion when at a meeting of the FWRF. That was a proposal removing the need for consensus in the Forum which was put down - thus ensuring that every vote is a 'fait accompli' for those involved with spending the HLS funds. There has only been one meeting held this year and the next one is not even scheduled yet. I am very much in favour of stream restoration if supported by the necessary required information that shows it will be beneficial.

The Claypits Bottom site was subject to a refusal of Planning Permission in 2016, (so how can heavy machinery and untested materials be allowed to infill - yet again - the headwaters of Latchmore Brook which a Southampton University Geologist dated as pre English Channel).

Also my query that a specific HRA of the potential effects of the sediment flows on the stream flora and fauna, (it is known that rare fauna and flora were present in and beside the stream at the site) has not been addressed at Claypits Bottom. It would be extremely helpful if all maps, surveys, instructions to contractors, costs in relation to this work could be made available.

The agreed 8 point strategy of the "New Forest Freshwater and Wetland Habitats Restoration Strategy 2019" is being ignored - with my apologies for repeating just the first Principle:

"Set clear objectives and expected outcomes with timescales. Cost and implement a

survey and monitoring programme to collect the baseline and post-restoration evidence necessary to robustly check outcomes are being met."

As the National Audit Office reported in their letter of 31 July 2017: "It is important that scheme benefits are measured and evaluated against baselines to inform the design of future projects and that sufficient attention is given to post-project evaluations to assess value for money."

The public attend the court regularly because they care about the Forest and want to hear it is being looked after to the highest possible standard. I ask that the Official Verderer as Chair of "The Verderers of the New Forest Higher-level Stewardship (HLS) Scheme" ensures that every possible measure is taken to protect this precious place which has the highest designations of protection by at least following the agreed points of the strategy of the FWRF. Thank you for your attention'

The common rights argument is not a planning matter. The Clerk will write to NHS Property Services. Mr Grugeon will advise her who he is in touch with. The letter will setting out the concerns which were raised in the presentment. Mr Grugeon requested a copy. The Clerk will also suggest the NHS carries out a common rights search.

Mr Pasmore's view is that Habitats Regulations Assessment (HRA) is not sufficiently wide ranging when undertaken in the New Forest. It considers the ecology but not the aesthetics. In response the DS said the HRA assent covers a specific set of nature conservation interests. It was then suggested to the DS that the HRA does not address the impact of interaction between humans and livestock.

The DS was asked to provide a copy of the HRA for the Big Feat Event as well as the route. The same was requested for the forthcoming large orienteering event which will be held in the same area. A copy of the Tranquil Areas Map was also requested. These papers are requested before the November Court.

In addition, the temporary fence erected to protect the Warden's units on this site is still in situ. It is accepted that the term 'temporary' was not actually defined when permission was granted. The Court asked that Camping in the New Forest make a formal application if it wishes the fence to remain. The Court will insist that at least two gates must be locked open to allow for stock to range freely within the enclosure.

When identified, the owner of an animal which causes injury will always be first in line if a claim for personal injury/damage is made by an injured party. However, the Agisters are extremely concerned that they may be vulnerable as a result of a decision they make regarding what action should be taken in respect of an alleged troublesome animal. Mr Deakin said the Agisters need strong guidance from the Verderers in order to provide greater protection. He felt the current situation cannot continue.

The future of camping on the open Forest and whether the campsites should now be fenced was discussed with differing views expressed.

However, there are significant difficulties should it ever be agreed that fencing be introduced, not least the legislation that protects the common land of the New Forest.

It is recognised that the campsites represent a significant income stream for FE. It was suggested that in the case of a commoner being subject to a claim for injury/damages caused by an animal in his ownership, he/she could, in turn, sue FE. Mr Gammon felt that is possible with the commoner joining FE as a co-defendant. The Official Verderer said he does not support fencing. He said the dangers to the public are on the open Forest generally. Some other members of the Court disagreed and feel fencing may be the only option. At present FE benefits from the campsite and other recreational activities and the commoners suffer.

Several actions were agreed.
