2022/12503 MINUTES OF THE LAST MEETING

RESUME

The minutes of the last Court held on Wednesday 21st September 2022 were approved and signed by the Official Verderer.

2022/12504 NEW DECLARATIONS OF INTEREST

RESUME

There were no new Declarations of Interest.

Declarations of Interest forms have been added to our website in respect of Mr Gammon and Mr Chatters.

2022/12505 CONDITION OF STOCK

RESUME

The Head Agister reported that the Agisters are getting through the drifts, with the majority of the ponies caught being in really good condition. As always, mares with foals are easy to see as their condition is not quite as good. There is a good fit and healthy foal crop this year. The animals have had a good summer despite the hot, dry weather and most are looking good going into winter.

A few cases of strangles are still appearing, however, the disease is not widespread and it appears to be affecting individual animals in the Longdown, Deerleap and Ashurst areas with one suspected case on Bolton's Bench. The drifts are being cancelled in those areas to avoid the risk of spreading the disease further, or stressing animals which have the illness.

A lot of cattle are now being removed from the Forest, partly due to acorns and partly as the TB testing window for the Forest herd is now open. There have been difficulties with TB testing where breakdowns affecting the Forest have resulted in TB testing being required outside the window. Generally, DEFRA staff do not understand the difficulties commoners face getting their animals in off the Forest during the summer. DEFRA is generally happy with TB testing being carried out a little early but not late. The situation is frustrating but is beyond the control of the Court or Commoners.

There have been a few cases of acorn poisoning, resulting in the deaths of the animals affected. There are fewer than expected as the acorns have come down steadily rather than all at once. However, deaths due to acorns can continue until Christmas. Cattle as well as ponies are affected.

2022/12508 NEWLY APPOINTED VERDERERS - MARK GAMMON & CLIVE CHATTERS

We are very pleased to welcome Mr Mark Gammon and Mr Clive Chatters to our Court today.

As announced by the Deputy Surveyor in July, Mr Gammon has been appointed by Forestry England as its representative on the Court. Today is, however, Mr Gammon's first time in attendance. Mark is a retired senior Crown prosecutor who specialised in wildlife crime and animal cruelty offences. Previously he was a solicitor in private practice and he has a good understanding of enforcement. Mark has lived in the Forest for many years and he has a good working knowledge of local wildlife and conservation.

Mr Clive Chatters is Natural England's newly appointed Verderer. Mr Chatters brings with him a wealth of knowledge and experience of conservation issues in the New

Forest and beyond. He has a considerable understanding of the pressures arising from the need to balance the interests of agriculture, conservation, and recreation in the Forest

We are confident both will prove to be very valued members of the Court.

2022/12509 DOGS

Peter Roberts made a presentment in July, urging this Court to pressurise Forestry England into changing its bylaws so that dogs are only allowed on the Forest on short leads in the bird nesting season.

There is no doubt that ground nesting birds are under very significant pressure in the New Forest and indeed elsewhere. Loss of suitable habitat, predation and disturbance are the three key factors. All three need to be addressed satisfactorily to ensure that ground nesting birds such as curlew and lapwing can breed successfully.

Mr Roberts objects to the strapline of NFDog "on the Forest, off the lead". However, it is right to point out that its website also says" Keep to the main tracks when birds are nesting on the ground (usually March to July)".

The Verderers have been engaging constructively with NFDog for some time to support and encourage its work which seeks to ensure that all dog walkers exercise their dogs responsibly when on the Forest. That engagement continues and our discussions will focus on, amongst other things, the need to achieve maximum protection for ground nesting birds in the nesting season from disturbance by dogs.

The Verderers do not rule out the possibility of seeking a change in Forestry England bylaws at a future date.

2022/12510 BRAMBLES

Concern was expressed by Mary Gray about the extent of brambles on the open Forest. The Verderers agree that bramble needs to be managed on the Open Forest especially where it encroaches on valuable grazing. I understand that Forestry England manage brambles and will continue to do so. Browsing by deer and commoners' livestock contributes to that management. It may be of interest to those present to know that there are many species of bramble in the Open Forest which straddles two of the richest regional bramble floras in Britain with its heathland and pasture woodland soils.

2022/12511 CYCLING

At our last court the New Forest Association reported from its bylaw watch over 700 instances of cycling off the way marked routes in a period between 25th July and 31st August this year.

Regrettably this came as no surprise. The Verderers have over many years expressed to Forestry England their concerns about the ever increasing amount of cyclists who regularly trespass off the approved cycle routes. In recent months we have expressed those concerns both to the Deputy Surveyor and his team and direct to the Chair of Forestry England, providing information about the scale of the issue and its consequences. The result of the New Forest Association's recent byelaw watch, emphatically reinforces what has been said by the Verderers to Forestry England many times. This is an issue which can no longer be treated by Forestry England as a low priority.

In commenting on this it is all too easy to characterise the Verderers as anti-cycling. That is emphatically not the case. The Verderers are very well aware of the many benefits of cycling and support the existence of the Cycle network. I am not the only Verderer who makes use of the network from time to time.

It is therefore a good time to set out the Verderers' position in relation to cycling off the approved cycle routes.

Cycling on the Forest is prohibited by Forestry England bylaws (bylaw 6). This is to be contrasted with the position of those on foot who have access to the Forest by right as do horse riders. The grazing stock is also there by right and delivers enormous conservation benefits. The grazing stock has shaped and continues to maintain the Forest's mosaic of rare, interesting and important habitats.

The Forest of course provides excellent recreational opportunities. However, it is also a working forest and an area of remarkable conservation importance and rarity designated as a SAC (Special Area of Conservation) and SSSI (Site of Special Scientific Interest). Critically it still retains strong elements of a wilderness with areas where both nature and the stock are left largely undisturbed.

In 2015 a study resulted in the drafting of a map, identifying the level of disturbance across the Forest. The Forest was divided into 5 zones. Zone E was the most tranquil, where there were no well-used cycle tracks and no moderate passive recreation. Zone D in which there were no camp sites and there was no intensive passive recreation. Zone C had no all-year campsites greater than 150 pitches. Zones B and A were the least tranquil. The Tranquil Areas map has been used to reduce and where possible eliminate, disturbance from activities, including organised recreational activities which would significantly impact nature conservation in those sensitive areas.

However, the advent of the mountain bike and now electrically assisted bicycle means that it is ever easier to access vast areas of the Forest. They have contributed to the significant increase in the number of cyclists all over the Forest. Headlamps now throw a beam many metres ahead which can be seen from far away; these facilitate more and more night time cycling, apparently regardless of the impact on nocturnal animals. Tyres often incise into the soft ground, contributing to erosion and as one track becomes impassable another is created. As more and more houses are built within easy driving distance of the Forest the recreational pressure, including cycling, will only increase.

The Verderers recognise that different types of route cater for different cyclists. Some wish to travel from A to B. Others wish to use a circular route returning usually to the car park from where they started. The Verderers do not rule out participating in a review of the Cycle network but such a review must be against the backdrop of control of illegal off route cycling. In any such review preservation of the tranquil and undisturbed areas, links to the car parks, the interests of nature conservation and protection of the fragile environment together with the interest of the commoners must be taken into account as well as the interests of those who wish to use the Forest for recreation.

The issue of concern is not that of the cyclist who gets lost, or the family who inadvertently strays from the network. The issue is those who persistently flout the byelaw. Dog owners whose dogs harass or attack stock are dealt with by the police as are those who drive motor vehicles over the Forest without permission. The Verderers ensure that the commoners comply with our bylaws. Forestry England

must ensure that its bylaws are policed and enforced. That is the only right and proper course and it is in the best interests of the Forest.

The Verderers therefore call upon Forestry England to take the following actions: -

- Acknowledge that off route cycling is widespread.
- Ensure that both the free maps and paid for cycle maps are fit for purpose so that cyclists can easily identify and follow the approved route.
- Sign each and every carpark under its control so that the public is clearly informed as to whether or not cycling is permitted and possible from that car park.
- 4. Ensure that online mapping records the approved cycle network and unapproved routes are removed.
- 5. Review and if necessary, improve the physical way marking of the approved routes.
- 6. State publicly, including in this forum, firstly what its policy is in relation to enforcement of its bylaws, and secondly that it will prosecute persistent offenders.

2022/12512 MARKING FEES FOR 2023

After much debate and discussion in Committee, we regret that marking fees for 2023 will have to increase.

The marking fee for ponies, cattle and donkeys on the Forest will be increased by £2.00 to £26.00 per head.

The Common rate of marking fee, for those commoners whose animals qualify, will be £13.00 per head for ponies and donkeys and £3.25 per head for cattle, which is 1/8th of the Forest fee.

Marking fees for sheep also increase by £2.00 per head. Sheep on the Forest will therefore be £10.00 per head and on the Commons, it will be £5.00 per head.

The marking fees for pigs remain unchanged. On the Forest they are £4.00 per head and on the commons £2.00 per head.

ANIMAL ACCIDENT REPORT

2022/12513 THE ANIMAL ACCIDENT REPORT FOR SEPTEMBER 2022

The Agisters attended 6 accidents in September this year, compared with 16 in the same period last year.

3 ponies and 1 cow were killed, 1 pony was wearing a reflective collar.

1 pony and 1 cow were injured.

No accidents occurred in daylight, 2 occurred at twilight and 4 in the dark. All the drivers involved reported having been involved in an accident.

The total number of commoners' animals killed and injured to the end of September is 33, compared with 39 to the end of September last year.

2022/12514 PANNAGE

Presentment by Mr Brian Ingram, Commoner

Mr Ingram asked if the pannage season can be extended in view of the heavy acorn crop this year. He remarked that animal deaths due to acorn poisoning can go on into February next year.

Members of the Court were involved in a virtual meeting to go through this document which sets out the procedures BT Openreach will follow when undertaking works in the Forest. There are no issues of concern in the agreement. Individual proposals will continue to come to the Court for consent in the usual way.

2022/12520 DMMO 1231 SANDFORD (RINGWOOD) TO BURLEY RESUME

The Clerk was asked to ensure this proposal is properly described. It does not involve Kingston Great Common.

Mr Grugeon has asked Hampshire County Council for a copy of its legal advice on the designation of rights of way by prescription over Action PG Crown Lands.

HCC's Strategic Access Manager will make the decision on behalf of the County Council, as to whether or not any public rights of way should be added to the Definitive Map. HCC will not share the reports prior to making the decision, the report will however be published afterwards. If HCC decides to make an order, the Clerk will be advised and an objection to the order can be made within the advertisement period. If an objection to an order is received, HCC is required to send the application to the Planning Inspectorate for determination on behalf of the Secretary of State.

ANY OTHER BUSINESS INVOLVING FORESTRY ENGLAND

2022/12528 THE RECREATION DIARY AND LARGE EVENTS

RESUME

The Court expressed concern that on 25th September 2022, a large recreational event was permitted in one of the Forest's designated tranquil areas. The event, which the Recreation Diary stated involved approximately 150 runners, comprised 4 separate routes, over parts of the Crown Lands, National Trust Commons and Hampshire County Council's Common. The Court asked how this could be permitted by FE. It is assumed the NT and HCC gave consent. A large inflatable arch was seen to have been erected on HCC's common.

The DS said that the event covered a small area of Crown Land and it was subject to a Habitats Regulations Assessment (HRA). It was approved by the local Keeper and FE's Ecologist. However, the Court felt the event violated the tranquil area and that passing an HRA is not the be all and end all. The event was felt to be an unnecessary intrusion which may have involved more runners than was claimed.

The concern of the Court is that the organisers will want to repeat the event next year and the DS was asked to provide some feedback regarding the actual numbers taking part, what monitoring took place and also what weight FE now gives to the principle of the tranquil areas.

2022/12529 WOODGREEN CELEBRATORY TREE APPLICATION REVIEW

DISCHARGE

The Parish Council has looked again at its proposal and has suggested a Rowan tree would be more suitable than a larger species.

The Court accepted this revised proposal but stipulated that the Rowan must be a British Native tree species. In future, such applications will have to be accompanied by a plan for both FE and the Court to consider. The Clerk will advise the Parish Council.

2022/12530 ROADSIDE VERGE CLEARANCE

RESUME December

A lot of discussion has taken place recently regarding FE's four-year cycle for verge clearance. Unfortunately, this is felt to be insufficient to ensure the safety of Forest stock with two years being much more effective. The Court requested FE to operate a 2 year cycle and to clear a wider strip, in the region of 10m from the roads, in order to provide clear unimpeded visibility for drivers. It is hoped some funding may be available from the HLS to cover the additional work.

It was reported that on the corner by Abbotwell, there is a large bramble bush that is seriously impacting visibility.

It was also pointed out that in years gone by, HCC used to do some clearance of roadside verges. Mr Grugeon explained that HCC has a licence to carry out certain activities within 5ft of the highway. This comprises signage, ditch and ragwort clearance. It is thought that verge clearance is no longer carried out by HCC, but is left to FE.

2022/12531 A31 BOUNDARY FENCING

DISCHARGE

National Highways has put forward a proposal to replace some of the A31 fencing with recycled plastic fence. After very careful consideration of the information provided, the Court agreed to support a trial length. The Clerk will advise National Highways accordingly.

DISCHARGE

The Court returned to this subject. It was suggested that some 8 acres of grazing on Blackfield Common has been lost to brambles. FE is going to try using the forage harvester on brambles at Stoney Cross and depending on the result, it may be possible to do the same elsewhere.

The Clerk advised the writer had already contacted her and she had advised him to wait until next year as a lot may depend on the acorn crop. The Court agreed the decision should be deferred until next year but it is felt it is unlikely the request will be agreed, due to previous problems when pigs were turned out in the area under a right of common. Those pigs did not remain on the common for long as the owner spent a lot of time retrieving them from private property where fencing was inadequate. There is nothing to suggest the fencing has improved over the years.

RESUME

The question of whether pigs are allowed on the Western Commons was revisited but once again no firm conclusion was reached. The question seems to be the definition of the right of common of pasture, which appears to vary according the common land involved. Commoners depasturing pigs on, or adjacent to the Western Commons, need to satisfy themselves that they have the relevant right. If they haven't, there may be some associated risks. A letter OV/RD/Clerk to affected commoners may be required.

2022/12558 CATTLE AT HILLTOP

RESUME

Concern has reportedly been raised in some quarters that not enough is being done to protect the public from a herd of cattle that runs in the Hilltop (Beaulieu) / Dibden area of the Forest. These cattle are said to have been implicated in a number of incidents. some of which have been reported to the Court. Such incidents have been swiftly acted upon and appropriate action taken - such as the Verderers taking action under their byelaws when justified. The Court felt it was not its responsibility to pay the owner of the cattle to remove their horns. The Court does not have the power to insist on removal. The office had been required by HSE to provide details of the cattle owner but it was not known whether any action had been taken.

It was agreed that it may be advisable to write to the owner of the cattle, explaining that a number of reports about the behaviour of his animals have been received.
