2021/11832 RECENTLY APPOINTED DEPUTY SURVEYOR

I would like to take this opportunity to welcome Craig Harrison, the recently appointed Deputy Surveyor, to his first meeting of the Verderers court.

Craig follows in the footsteps of many illustrious predecessors but I am sure that will not daunt him.

The Forest faces many challenges some old, some new and the role of the Deputy Surveyor in tackling those challenges is crucial. On behalf of the Verderers I look forward to working with the Deputy Surveyor for the good of the Forest.

2021/11833 PIG KILLED BY DOG

Kathleen Brady, from Southampton, pleaded guilty in the Magistrates Court, to being the owner of a dog that worried livestock, in this case a pig, on the Forest at Ashurst, on 5th November 2020.

She has been ordered to pay the owner £200 compensation, she was fined £300 and told to pay £115 Court costs.

We are grateful to the Police for pursuing this case to Court and we hope it will serve as a lesson to dog owners that they must keep their dogs under control.

2021/11834 FEEDING OF FOREST ANIMALS

There is a glut of apples and other fruits this year.

Depositing fruit or anything else on the Forest, especially near or on the roadside, that may be eaten by Forest animals, is extremely dangerous and inconsiderate. It encourages animals to the roadside and puts them at greater risk of being involved in road traffic accidents. Even if it is not by the road, depositing anything anywhere for the Forest animals to eat creates a potential risk. Consuming too many apples may give a pony or donkey fatal colic. It also leads to aggression and injury as animals compete for the food.

Another problem we regularly see at this time of year is hay being dumped on the Forest, sometimes in large quantities. It is usually old hay that horse-owners feel is no longer suitable for their riding horses and they think that dumping it on the Forest is a good way of getting rid of it. Again, it can cause problems for the animals if it is mouldy or dusty and if animals compete for it. If it isn't good enough for your horse, it isn't good enough for the Forest ponies.

Depositing anything on the Forest constitutes fly tipping and if the culprit is identified, he or she may be prosecuted in the Magistrates Court.

2021/11835 VERDERERS' ELECTION

The Election of three Verderers, will be held on Friday, 26th November, when the terms of office of Anthony Pasmore, Richard Deakin and Jim Greenwood come to an end.

The deadline for registering to vote at our election is this coming Friday, 17th September. The Draft Electoral Register has then to be finalised, in time for it to be sent out to the public offices for public viewing from Monday 1st October. The fact that you may have been registered for previous elections does not count, and therefore, to be able to vote this year, you must register now. I hope we will see a strong turnout at the election and I ask all those present to help spread the word so that as many people as possible are able to vote. I very much hope the press will also help by giving publicity to this important event.

2021/11836 RESPONSE TO PRESENTMENT FROM JULY ON CAMPSITES

The OV said that having looked at our protocol for dealing with presentments, he feels it is a matter that FE needs to respond to by a presentment in Court. This was agreed.

The DS said FE has spoken to Camping in the Forest and its campsite wardens reiterating that disposable BBQs and open fires are not allowed in the controlled environment of a campsite. This will be ongoing.

PRESENTMENT BY THE DEPUTY SURVEYOR

2021/11837 NEWLY APPOINTED DEPUTY SURVEYOR by Mr Craig Harrison

2021/11838 BRIDGES

Presentment by Mrs Charlotte Lines, Chair, New Forest Commoners Defence Association

'It has been reported through the NFCDA committee that several bridges are in urgent need of repair/replacement (please see pictures below). As you can see, they present a danger for Forest users and livestock. Locations include Longwater, Denny Lawn, Markway, back of Ashurst Lodge, Busketts Inclosure, and Furzey lawn.

We understand that the bridge at Furzey Lawn was reported in June and nothing has been done to date. In some cases people have filled the holes with various items such as a concrete, and wood which presents further risk.

We believe the issue around bridges was raised at the last Verderers' Court and it would appear that repairs have not been carried out. We hope we can get some assurances from the court that the repairs will be instigated as a priority matter, before there is a serious incident.'

2021/11839 BRIDGES

RESUME April 2022

The Furzey Lawn Bridge is a particularly bad example of a bridge needing repair. It is considered to be extremely dangerous and is the only way of crossing the stream. It has been awaiting repair for a long time.

Two damaged bridges near Ashurst Lodge and two in the Denny Lawn/Woodfidley area have also been reported to FE.

Ponies are accustomed to using the bridge near Ashurst Lodge during the drift. It is the route they always follow and they won't take any notice of tape across the ends of the bridge. The drift is on 8th October and the Court asked FE if the bridge can please be repaired by then. This bridge has been recognised as dangerous for a while and appropriate signage and tape put up, but members of the public have removed the tape.

In the past, there have been examples of animals putting a foot through a hole in a bridge deck. On one occasion a cow put its foot through a hole and was left hanging, caught by its foot. It lived, but was extremely difficult to extricate.

Concern was expressed at the constraints FE staff are under, and it is respectfully suggested that the FE process for repairing bridges is far too complex. Most bridges require little more than a board being replaced. An in-house Craftsman or contractor could do the job much more cheaply than the process using civil engineers. In some cases, the work needed to put rails across the ends of a bridge is actually greater than the repair.

The Deputy Surveyor said there are currently approximately eight bridges in FE's programme to be repaired soon. FE has a nationally set procedure for bridge repairs that must be followed locally. Repairs have been held up by the due process of contracts and procurement which, at present, is unavoidable. He noted that the programme doesn't match the bridges mentioned in the presentment and he will talk to his team about making sure the priorities are right. The DS said consideration will be given to where drifts are due to take place and every effort will be made to get bridges in those areas repaired first.

Action DS

The DS said he is interested in reviewing all FE's bridges in the Forest, to see whether any can be removed. The priorities are the needs of commoners and the Verderers/Agisters alongside FE's operational needs, and recreational interests. He suggested that where the bridges serve recreational interests only, it may be that FE may wish to remove them in order to create quiet areas. This is, however, all part of a wider debate which will take place in the future.

2021/11841 BT OPENREACH - JOINT BOXES

RESUME

Following on from the de-minimis report, a discussion took place concerning the joint boxes that Openreach usually needs to install at various points along its cable routes. NE has expressed concern at the loss of habitat from the siting of numerous surface mounted boxes. The Official Verderer said NE has arranged a Teams meeting next week to discuss this issue. Mr Deakin and Mr Dowsett asked to join the meeting. The Clerk will make the necessary arrangements.

DISCHARGE

Another issue is tarred telegraph poles. Mr Grugeon said he has been in touch with BT and SSE about what is acceptable.

PROPOSALS FOR UTILITIES WHICH FALL OUTSIDE THE REMIT OF THE DE-MINIMIS SYSTEM

2021/11843 BT PROPOSED FIBRE TO THE PREMISES PROVISION BETWEEN DISCHARGE EAST BOLDRE AND EAST END

This proposal is for new broadband provision for East Boldre/East End, V6002 – 350m new duct and V6005 – 519 new duct. This is Version 2 of an earlier proposal and the cable and joint boxes will now be put in the carriageway. These proposals were approved subject to the three usual conditions.

2021/11844 BURLEY LANDSCAPE IMPROVEMENT SCHEME

DISCHARGE

This is the scheme whereby overhead cabling is being buried and existing poles removed. A section of cable now needs to be buried in the verge past Burley Golf Course in order to avoid a road closure which would clash with the other nearby road closure connected with the replacement of the bridge carrying the A35 over the disused railway line.

Concerns were expressed over piles of sand that BT has asked to store (temporarily) on the Forest. FE's Sean Marsh is arranging a pre-works meeting during which this issue will be discussed.

The Court approved the proposal subject to assurance that the sand can be effectively removed from grazing. Mr Grugeon said he is investigating whether car parks can be used or the sand brought in aggregate bags.

2021/11845 UNEXPLODED ORDNANCE SURVEY AT CASTLE HILL

DISCHARGE

This survey is associated with the Burley Landscape Improvement Scheme. The only concern is the lack of any reference to the presence of free ranging livestock in the Method Statement. Mr Grugeon said consent at this stage is requested for the survey only. If it is necessary to undertake excavations or ordnance is found which needs to be blown up, additional consents will be requested.

The Court approved the proposals subject to a reference being added about ensuring the safety of the livestock.

MATTERS ARISING FROM PREVIOUS COURTS OF CONCERN TO FORESTRY ENGLAND

2021/11846 RE-FENCING OF DIBDEN INCLOSURE

RESUME November

The proposal to re-fence this inclosure has stalled, partly due to concerns expressed by Natural England but also because FE is now questioning whether re-fencing is necessary. The DS said a meeting with NE that was due to take place was postponed.

The Court's concerns about members of the public mixing with cattle in an area known for intensive recreational use, especially by dog walkers, were repeated. The Deputy Surveyor asked for time to acquire an understanding of the issues and consider what solutions might be available. The OV said

he is aware that Mr Deakin had a frustrating meeting with NE and he added if a further meeting takes place, he would like to attend.

2021/11847 FORESTRY ENGLAND INCLOSURES - LONG TERM STRATEGY

RESUME November

The problems associated with the removal of inclosure fences which are essential to ensure stock pounds are useable was explained to the DS.

Some fencing has been taken down as it is no longer required by FE. In places, lengths of fencing have subsequently been replaced and the Court has taken responsibility for some of these, but that is not financially sustainable in the long term.

The problem is increasing as more inclosures are thrown open. An estimated 80% of the pounds need an inclosure fence.

Given the stock is essential to the maintenance of the SSSI, the Court feels FE should therefore accept responsibility for fencing where it is essential for stock management.

On the recent Fawley drift, only about 50% of the ponies which the Agisters aspired to catch were driven in. The remainder got away due to lack of fencing that has been removed. The DS said he understands he need for a broad agreement in respect of fence maintenance and will consider the issue further. He is invited to attend a drift.

2021/11848 CAMPSITES

RESUME April 2022

The Court's position is clear. It seeks the removal of the three worst offending campsites, which are those where there are regular conflicts between campers and the commoners' animals and where the presence of the campsite is particularly damaging to the SSSI.

An anonymous email received by the Clerk from someone calling him or herself 'Concerned Camper' was forwarded to the DS prior to this meeting. Independent support for the content of the email has been received and also forwarded. An earlier presentment from the NFA also refers to the issues raised. The DS has been in touch with Camping in the Forest. A review will take place at the end of this season and training for campsite staff will be provided prior to next year's camping season. The CDA has offered assistance in achieving that.

The DS said FE recognises the impacts of campsites and is looking for a long-term solution which must take into account the positive impact camping has on the local economy.

2021/11849 PUBLIC SPACE PROTECTION ORDER

RESUME November

An update will be provided by Mr Richard Burke (FE) at the next meeting of the RMS group, on the way in which PSPOs have been used in large areas in Dorset. The OV wrote to the Leader of NFDC seeking support in principle and he is awaiting an answer.

The Court is keen on the use of a PSPO to proportionately manage and deter verge parking as well as potentially the various other issues which detrimentally affect the Forest, including feeding ponies, lighting fires, wild camping, cycling off the waymarked network, flying drones etc.

Concern was expressed at the lack of the RMS group's progress because it seems nothing has happened. The OV said he understands, but a significant amount of work is actually going on in the background, albeit it is not obvious.

2021/11850 ILLEGAL CYCLING

RESUME

The question of whether electrically assisted bicycles and/or electric bikes should be permitted on the waymarked cycle route was again discussed. Clarification is required. It was agreed that fully electrically powered bicycles (capable of substantially exceeding 15.5mph) are not acceptable but the Court needs to make a decision on electrically assisted bicycles. It was agreed a way forward is for the OV to make an announcement at the next Court saying that the Verderers are minded to agree to the use of electrically assisted bicycles on the waymarked cycle network and invite support or counter presentments at the next following Court.

Action OV

The Court asked FE to 'get a grip' of this issue before it is too late.

The DS said FE staff are doing their best to encourage people to use the waymarked cycle network and they are trying to stop off track cycling. FE has been liaising with local Police and seeking legal advice about enforcement. This has highlighted the complexity of the issue and a number of tests that need to be met to implement enforcement. He added that a proper consultation on cycling is going to be required and FE must take account of wide opinions.

The Court is extremely unhappy that no progress is being made and the DS was urged to look at what FE can do to deal with cyclists who persistently, and in some cases publicly, flout the rules and encourage others to do the same.

2021/11876 CONDITION OF STOCK REPORT BY THE HEAD AGISTER, JONATHAN GERRELLI

RESUME

Early September and we are now well into the drifts, and as usual some have gone better than others, but the one consistent thing has been the overall excellent condition of the ponies. Yes, you can generally see the mares that have a foal as they will be showing a bit of condition loss due to feeding of the foal, but even these are on the whole far better than usual. And the majority of the foals are also looking really fat and well. This is of course due to the amount of forage available on the Forest this year. I don't think I can remember ever seeing so much food for the stock out there at this time of the year as there is now. Certainly, no signs of over grazing!

The cattle are also doing well, and as there doesn't appear to be a very large crop of acorns I would expect them to be left out longer through the Autumn to take advantage of all the food available.

The donkeys have also been taking advantage of the good growing season and there are several large herds of them in various parts of the Forest, and there appears to be a lot more donkey foals around.

I don't think there will be so many pigs to go out as usual, due to the lack of acorns, but we are marking some.

2021/11877 ANIMAL ACCIDENTS – AVERAGE SPEED CAMERAS ON THE B3078 & THE OV'S MEETING WITH THE POLICE AND CRIME COMMISSIONER

RESUME

The OV reported on his recent meeting with the PCC and Cllr Edward Heron. Cllr Heron is confident he can obtain funding for a feasibility study, the cost of which is estimated to be in the region of £30,000. Cllr Heron is also confident that funding to cover the capital cost of average speed cameras on the B3078 can be secured.

It was, however, pointed out that a feasibility study was carried out some years ago and it is questionable whether carrying out another study can be justified. Mr Deakin will obtain a copy of the study if it is available.
